Dear Butler County DAR Member (and family/friends),

The Oxford Caroline Scott DAR Chapter is planning an America 250 DAR Washington DC trip in 2026. We will be using a travel company that has been working with school and adult groups (including DAR) for over 30 years, Martin School of Travel. They are committed to providing an affordable, fun, safe and educational trip for us. Our travel dates are June 3-7, 2026. In addition to our OCS members, we wanted to invite the rest of the Butler County chapters to join us!

Please read the information below regarding pricing options, and review the deposit information. There is also a payment schedule, but please note that this was just the suggested schedule for those who signed up right away. However, all initial registrations need to be completed by February 1.

Registration and payment are handled online at: <https://tri.ps/xctSO>. You can click on the blue letters to take you directly to the registration website, or type in the address on your computer. (THE LAST LETTER IN YOUR LINK IS A CAPITAL LETTER O, NOT A NUMBER ZERO)

Once you open the registration page, you will need to complete the following steps:

1. Choose a Package: On the right side, click on the green BOOK NOW button. You will select the rooming package that best fits your travel needs - Quad, Triple, Double, or Single - then select the payment option for registration. You can pay the first non-refundable deposit or pay the entire trip amount during the initial payment. Once you have chosen your package and your payment options, click the green CONTINUE button at the bottom.
2. Add Participant Info: Fill out all of the fields requesting passenger information. You will also be asked to make 2 meal choices at this point in the registration. Click the green CONTINUE button at the bottom.
3. Trip Protection Insurance: If you would like to add the Trip Protection, then just select the box to add it to Your Booking. The company recommends that you add the optional Trip Protection to your package. This will guarantee you can receive a full refund all the way up until the morning of departure should anything change that requires you to remove your traveler from the trip. Once you have made your selection, click the green CONTINUE button at the bottom.
4. Complete Payment: There are two payment options - US Checking Account "E-Check" and Credit/Debit Card. The "E Check" option is the most cost efficient and there are fewer processing fees. If you choose the "E Check" you will save 1.9% at checkout. All payments that are collected are secure payments. To finalize your registration, click CONFIRM BOOKING at the bottom.

On the confirmation page, check the box to make an account to easily make future payments. Just be sure to keep track of the email address you used for registration and save your password!

Once those 4 steps are completed, you are officially registered!

Once you make your initial payment, you will receive an email receipt confirming your registration. You will also receive reminder emails before your next payments - 7 days prior, 3 days prior and the day the payment is due.
